The setting is similarly unconventional, featuring a domestic scale and personal atmosphere. Artists represented in the collection include Pierre-Auguste Renoir, Vincent van Gogh, Pierre Bonnard, Pablo Picasso, Georgia O'Keeffe, Arthur Dove, Mark Rothko, Jacob Lawrence, and Richard Diebenkorn, among others. The collection has grown to include more than 1,000 photographs and works by contemporary artists such as Wolfgang Laib. The Phillips organizes acclaimed exhibitions, including its Intersections contemporary art series. The Phillips also produces K-12 and adult programs, while the University of Maryland Center for Art and Knowledge at The Phillips Collection is the museum's nexus for scholarly exchange.
